Introduction

1. Under s 27(1)(c) of the *Constitution Act 1902* (**the Constitution Act**) a redistribution of electoral boundaries must be carried out after two State General Elections have been conducted using the same electoral boundaries. The purpose of a redistribution of electoral districts is to ensure that, as far as practicable, each electoral district of the New South Wales Legislative Assembly has an equal number of electors (within a margin of allowance of 10 per cent more or less of the average enrolment in electoral districts at a specified future time).
2. The last redistribution was completed in 2013 and the State General Elections of 2015 and 2019 were conducted on the electoral boundaries determined at that redistribution. Accordingly, a further redistribution is required before the next State General Election in 2023.
3. Under s 20 of the *Electoral Act 2017* (**the Electoral Act**), if a distribution of electoral districts is required by the Constitution Act, the Governor is to advise the Electoral Districts Redistribution Panel (**the Redistribution Panel**) of that fact. The redistribution is then to be carried out by the Redistribution Panel established by s 17 of the Electoral Act. Under s 17, the Redistribution Panel consists of a current or former Judge appointed by the Governor as the Chairperson, the Electoral Commissioner and the Surveyor-General.
4. On 11 December 2019, Her Excellency the Governor appointed the Hon Arthur Emmett AO QC as the Chairperson of the Redistribution Panel. Mr John Schmidt, Electoral Commissioner for NSW, and Mrs Narelle Underwood, Surveyor-General of NSW, are the *ex officio* members of the Redistribution Panel.
5. The redistribution comes into effect for the March 2023 State General Election. Any State by-elections that take place prior to that election will be conducted on the applicable 2019 electoral district boundaries.

Process and timeframe

6. The process and timeframe for carrying out the redistribution, as specified in Part 3 of the Electoral Act, has been as follows.

1 Jun 2020	Notice published in the Government Gazette inviting written suggestions relating to the distribution of New South Wales into electoral districts, and any comments on such suggestions.
1 Jul 2020	Closing date for suggestions.
2 Jul 2020	Opening date for comments on suggestions.
3 Jul 2020	Suggestions lodged with the Redistribution Panel made available for public inspection on the Electoral Commission's website.
15 Jul 2020	Closing date for comments relating to any suggestions received.
20 Jul 2020	Comments on suggestions lodged with the Redistribution Panel made available for public inspection on the Electoral Commission's website.
Jun-Nov 2020	The Redistribution Panel considered all suggestions and comments lodged, as well as enrolment statistics and community-related factors, to produce the draft determination of the names and boundaries of electoral districts.
9 Nov 2020	Public notice given in the Government Gazette of the Redistribution Panel's draft determination of the names and boundaries of electoral districts inviting written submissions relating to the draft determination, and any comments on such submissions.
9 Dec 2020	Closing date for submissions on the draft determination of the names and boundaries of electoral districts.
11 Dec 2020	Submissions lodged made available for public inspection on the Electoral Commission's website.
10 Dec 2020	Opening date for comments on submissions.
23 Dec 2020	Closing date for comments on submissions on the draft determination of the names and boundaries of electoral districts.
24 Dec 2020	Comments received made available for public inspection on the Electoral Commission's website.
30 April 2021	Public hearing held in Sydney at which oral submissions were made to the Redistribution Panel by one individual and representatives of four registered political parties who had lodged a submission on the draft determination.
May-Jul 2021	The Redistribution Panel prepared a revised determination of the names and boundaries of electoral districts, having regard to all submissions and comments received and oral submissions made at any public hearing.
12 July 2021	The Redistribution Panel determined finally the names and boundaries of electoral districts.

The legislative framework

The *Constitution Act 1902*

7. The last redistribution was completed in 2013 and the State General Elections of 2015 and 2019 were conducted on the electoral boundaries determined at that redistribution. The current redistribution is conducted under section 27(1)(c) of the *Constitution Act 1902*, which requires a redistribution of electoral boundaries after two State General Elections have been conducted using the same electoral boundaries.
8. Section 28 of the Constitution Act provides that, upon a distribution of New South Wales into electoral districts, the boundaries of each proposed electoral district shall be so determined that, at the time the distribution is made, the number of persons entitled to vote at a general election of Members of the Legislative Assembly in each proposed electoral district is equal to a quotient from which the number of persons in each electoral district will not vary by more than ten percent (10%).
9. This quotient is obtained by dividing the number of persons enrolled at that time to vote at any general election in all the proposed electoral districts by the number of the proposed electoral districts at the time of the distribution, i.e., 93.

Criteria for distributions

10. Section 21(1)(a) of the Electoral Act requires the Redistribution Panel to have regard to demographic trends within the State and, as far as practicable, endeavour to ensure on the basis of those trends that, at the relevant future time, the number of electors enrolled in each electoral district will be equal, within an allowable margin of ten percent (10%) of the average enrolment in electoral districts at that future time.
11. Pursuant to section 21(2) of the Electoral Act, the 'relevant future time' for the purposes of this redistribution is 17 April 2023, being the date four years from the day of the return of the writs for the 2019 State General Election.

12. Section 21(1)(b) of the Electoral Act requires the Redistribution Panel to give due consideration in relation to each electoral district to:
 - (i) the community of interest within the electoral district, including economic, social, and regional interests;
 - (ii) the means of communication and travel within the electoral district;
 - (iii) the physical features and area of the electoral district;
 - (iv) any mountain and other natural boundaries; and
 - (v) the boundaries of the existing electoral districts.

Alignment with local government boundaries

13. In addition to the express requirements of section 21 of the Electoral Act, it was a common theme of the last two redistributions, and of much of the suggestions, comments and submissions received by Redistribution Panel, that a Local Government Area (LGA) can be equated to a community of interest.
14. Electoral districts in rural and regional NSW tend to be of such a size as to encompass more than one LGA, and dividing LGAs between electoral districts may cause administrative complexities. Therefore, in applying the community of interest criterion the Redistribution Panel considered that giving particular consideration to local government boundaries in rural and regional NSW was a desirable approach.
15. Having said this, in Greater Sydney that approach cannot be so readily applied. Unlike electoral districts, LGAs are not based on population. Accordingly, many urban councils with larger populations necessarily extend across more than one electoral district in this determination.

Recommendation for legislative change - commencement of the statutory comments periods

16. The current redistribution is the first to have been conducted under the provisions of Part 3 of the Electoral Act. Section 22(2)(b) of the Electoral Act provides that the fourteen-day period for lodging written comments on suggestions commences on the expiry of the suggestion period; section 25(2)(c) makes similar provision in respect of comments lodged on submissions.
17. However, sections 22(3) and 25(3) of the Electoral Act respectively require the Redistribution Panel to make a copy of any comments lodged on suggestions or submissions available for public inspection on the Electoral Commission's website *as soon as is reasonably practicable* after the expiry of the relevant period.
18. The operation of sections 22(2)(b) and 22(3) and sections 25(2)(c) and 25(3) inevitably results in a period in which the relevant comments period commences before there is any reasonable possibility of the Redistribution Panel having all of the suggestions or submissions available for public inspection on the Electoral Commission's website.
19. Accordingly, the Redistribution Panel suggests that consideration be given to amending sections 22(2)(b) and 25(2)(c) of the Electoral Act to provide that the fourteen-day period for lodging written comments commences on the day on which suggestions or submissions are made available for public inspection on the Electoral Commission's website.

Enrolment data, quotient variance and trends

Recognised demographer

20. In accordance with section 23(2)(a) of the Electoral Act, the Redistribution Panel engaged a demographer, namely I.D. Consulting Pty Ltd (**the demographer**), to prepare projected enrolment numbers by SA1¹ for the purpose of defining enrolment statistics at the relevant future date.
21. In April 2020, the demographer provided the Redistribution Panel with an accompanying narrative, titled *Voter Trends Report*, which highlighted longer-term patterns of enrolment change. A copy of the *Voter Trends Report* is available on the Electoral Commission's [website](#).

Enrolment data

22. As at 23 March 2020, five of the 93 existing electoral districts were more than 10% above the quotient. Additionally, a further thirteen electoral districts had variations from the quotient of over 5%.
23. The NSW Electoral Commission published the *Current and Projected Enrolment by SA1* data on its website prior to the commencement of the suggestions phase. This dataset provided the current 'snapshot' of persons enrolled in NSW as at 23 March 2020, as well as the projected number of electors at the 'relevant future date' of 17 April 2023.

Enrolment trends

24. The *Voter Trends Report*, referred to above,² summarised the forecasts and highlighted patterns of projected change over a ten-year period from the current enrolment date to 2029. It focused on two components, namely:
 - (i) The growth in electors, with reference to the drivers of the underpinning growth in Estimated Resident Population (ERP) aged 18 and over; and
 - (ii) The difference in elector share between areas that creates a variation between growth in adult (18 and over) population and electors.³
25. These projections were used as the basis for calculating the current and projected variance from the statutory quotient of the electoral districts for this determination.

Potential demographic impact of COVID-19

26. The Redistribution Panel considered the potential impact of COVID-19 in making the draft determination. The Redistribution Panel noted in the report accompanying the draft determination that it would continue to monitor this issue.
27. Accordingly, in May 2021 the Redistribution Panel sought from the demographer an analysis at the NSW metropolitan, regional and SA4 levels of the potential impact of COVID-19 on New South Wales enrolment projections to 2029. The analysis provided by the demographer, *Review of the impacts from COVID-19 on voter forecasts*, is available on the Electoral Commission's website.
28. As a result of their analysis, the demographer concludes that the enrolment forecasts on which the Panel's draft determination were based remain valid into the future, despite the impact of COVID-19. The report notes generally as follows:

While it is likely that that the relationship between adult population and voter growth has changed during this period, it is assumed that the underlying voter growth has continued, creating a good match to the existing population forecasts. The SA4 data suggests that the existing population forecasts are tracking relatively well, at least at the broad level in 2021.⁴
29. With respect to the potential for the boundaries set out in the Redistribution Panel's draft determination to trigger malapportionment under s 28A of the Constitution Act,⁵ the demographer concludes that:

...this assessment affirms that the proposed electoral boundaries remain valid into the future, despite the impact of COVID-19. The revised forecasts, including the impact of COVID-19 on population, suggests that three districts (**Heffron**, **Upper Hunter** and **Camden**) may fall outside the 5% quotient. There are already two districts that are forecast to be outside of the quotient in 2023 (**Barwon** and **Cootamundra**). These five potential variations from the quotient in 2023 represent a small share (5.4%) of the total 93 proposed electoral districts.⁶

Carrying out the redistribution

Suggestions and comments phase

30. Due to uncertainty caused by the outbreak of the COVID-19 pandemic, the Redistribution Panel did not commence the redistribution suggestion phase until 1 June 2020. To assist stakeholders in preparing their suggestions prior to commencement of the formal consultation process, the Redistribution Panel gave public notice on 20 April 2020 that the redistribution would be carried out, and encouraged anyone interested to view the current electoral district maps and enrolment data on the NSW Electoral Commission website.
31. Forty-one (41) suggestions on electoral districts were lodged with the Redistribution Panel during the initial month-long consultation period in June 2020; in the 14-day comments period which followed, the Panel received ninety (90) comments on these suggestions.
32. The suggestions and comments are available on the redistribution website in accordance with section 22(3) of the Electoral Act.

Draft determination of the names and boundaries of electoral districts

33. On 9 November 2020, pursuant to section 25(2) of the Electoral Act, the Redistribution Panel gave notice that the following were available for inspection on the Electoral Commission's website:
 - (i) maps setting out the Redistribution Panel's proposed names and boundaries of electoral districts; and
 - (ii) the Panel's reasons for making the draft determination.
34. The key proposals in the draft determination were as follows:
 - The electoral district of **Lakemba** was abolished.
 - The electoral district of **Leppington** was created.
 - The following five electoral districts were re-named:
 - **Badgerys Creek** – formerly **Mulgoa**
 - **Kellyville** – formerly **Baulkham Hills**
 - **St Ives** – formerly **Davidson**
 - **Wahroonga** – formerly **Ku-ring-gai**
 - **Winston Hills** – formerly **Seven Hills**.
 - Apart from minor adjustments to district boundaries for improved cadastral (property boundary) alignment, no changes were proposed to the boundaries of the electoral districts of **Balmain**, **Barwon**, **Bega**, **Coffs Harbour**, **Cronulla**, **Kiama**, **Pittwater**, **South Coast**, **Terrigal** and **Tweed**.
 - In addition, the only changes proposed to the electoral districts of **Orange**, **Port Stephens**, and **Wagga Wagga** were slight boundary adjustments with minimal enrolment transfers.

Submissions and comments on the draft determination

35. As required by section 25(2)(b) and 25(2)(c) of the Electoral Act, the Redistribution Panel invited written submissions relating to the draft determination to be lodged no later than 9 December 2020; and any comments on such submissions to be lodged with the Panel no later than 23 December 2020.
36. Seventy-seven (77) submissions and eight (8) comments lodged with the Panel were made available for public inspection on the NSW Electoral Commission's website as soon as practicable after the close of the relevant period:

37. No submissions were lodged in respect of the draft determination of boundaries of the following electoral districts:
- Bathurst
 - Blacktown
 - Blue Mountains
 - Camden
 - Charlestown
 - Clarence
 - Lake Macquarie
 - Lane Cove
 - Maitland
 - Manly
 - Maroubra
 - Newcastle
 - Port Stephens
 - Prospect
 - Riverstone
 - Wagga Wagga or
 - Wallsend.
38. One submission was lodged objecting to the draft determination of boundaries in respect of each of the electoral districts of:
- Albury
 - Ballina
 - Coogee
 - Cronulla
 - Drummoyne
 - Lismore
 - Mount Druitt
 - Shellharbour
 - The Entrance
 - Vacluse
 - Willoughby
 - Wollondilly and
 - Wyong.
39. Two submissions were lodged objecting to the draft determination of boundaries in respect of each of the following electoral districts:
- Goulburn
 - Monaro
 - Murray and
 - Port Macquarie (other than in respect of Lord Howe Island).
40. The Redistribution Panel considers that these figures show a general acceptance of the proposals in the draft determination, especially in respect of rural and regional New South Wales.
41. The one exception to this general pattern was that a total of 32 submissions were lodged in opposition to the Redistribution Panel's proposal that Lord Howe Island be transferred from the electoral district of **Port Macquarie** to the electoral district of **Sydney**.
42. The Panel considered all submissions and comments lodged. The Redistribution Panel is grateful to all who provided suggestions, submissions and comments in connection with this redistribution.

Public hearing

43. Section 26 of the Electoral Act provides that the Redistribution Panel must hold a public hearing into the submissions and comments lodged in relation to the draft determination unless of the opinion that the matters that were raised in the submissions and comments lodged in relation to the draft determination were raised in the initial round of suggestions and comments, or are substantially the same as those matters.
44. The Redistribution Panel accepted that some of the submissions and comments made in relation to the draft determination were not raised in the initial round of suggestions and comments. Accordingly, the Redistribution Panel held a public hearing into the submissions and comments on the draft determination on 30 April 2021 at the Wesley Conference Centre, Pitt Street, Sydney.
45. Section 26 provides generally that the Redistribution Panel may regulate the conduct of a public hearing as it considers fit, and guidelines were distributed for the assistance of anyone wishing to participate in or attend the public hearing, either in person or virtually. Pursuant to section 26(3) of the Electoral Act, all individuals and organisations who had lodged written feedback on the draft determination were invited to make oral submissions. While a time limit was not set for oral addresses, participants were required to confine their addresses to matters that were the subject of the submissions and comments lodged in relation to the draft determination.

46. At the public hearing, further submissions were made to the Redistribution Panel by the following:

 - Mr Chris Stone, State Director, and Mr Nick Westenberg, Deputy Campaign Director on behalf of The Liberal Party of Australia (NSW Division).
47. In the course of the public hearing, the Redistribution Panel heard submissions on the names or boundaries of the following electoral districts:
- **Drummoyne** – Mr Shaw;
 - **Kogarah & Oatley** – Australian Labor Party (NSW Branch) and the Liberal Party of Australia (NSW Division);
 - **Newtown & Sydney** – The Greens NSW;
 - **Cessnock & Upper Hunter** – The NSW Nationals;
 - **Ballina, Lismore, Myall Lakes, Oxley & Port Macquarie** – The NSW Nationals;
 - **Cronulla, Heathcote & Miranda** – the Liberal Party of Australia (NSW Division);
 - **Heathcote** – the Liberal Party of Australia (NSW Division);
 - **Holsworthy & Liverpool** – the Liberal Party of Australia (NSW Division); and
 - **Londonderry & Penrith** – the Liberal Party of Australia (NSW Division).

The revised determination

49. Pursuant to section 27 of the Electoral Act, as soon as practicable after the Redistribution Panel has concluded its consideration of any submissions made to it, the Redistribution Panel must consider its draft determination and prepare a revised determination of the names and boundaries of electoral districts.
50. Section 27(2) provides that if the Redistribution Panel is of the opinion that its revised determination will not be significantly different from the draft determination, the Redistribution Panel is to determine finally the names and boundaries of electoral districts.
51. In deciding whether the changes to names and boundaries of electoral districts under consideration would render its revised determination *significantly different* from the draft determination, the Redistribution Panel took into account matters such as:
- (i) The number of proposals for change, in the light of the 93 electoral districts to be determined;
 - (ii) The geographic size and spread of any proposed changes;
 - (iii) The number of electors potentially affected by the proposed changes; and
 - (iv) Any material lodged previously with the Redistribution Panel in relation to any individual proposed change.
52. Having regard to these criteria, the Redistribution Panel determined that the changes to the names and boundaries of electoral districts agreed upon by the Redistribution Panel in the light of:
- the submissions lodged on the draft determination;
 - the comments lodged on those submissions; and
 - the further submissions made to the Panel at the public hearing of 30 April 2021,
- did not render the Panel's revised determination significantly different from the draft determination of November 2020.
53. There was therefore no need for the further public consultation process set out in section 27(3)–(9) of the Electoral Act to occur, and, accordingly, after receipt of a further report from the demographer, the Redistribution Panel finally determined the names and boundaries of electoral districts as set out herein.

Variations from quotient

54. Thirteen of the electoral districts finally determined by the Redistribution Panel have current variations from the quotient of greater than five percent. These are **Barwon** (-5.42), **Cabramatta** (+6.65), **Castle Hill** (+5.91), **Heffron** (-9.46), **Hornsby** (+5.11), **Kellyville** (-7.52), **Leppington** (-9.77), **Londonderry** (-9.77), **Mount Druitt** (+6.27), **Parramatta** (-8.16), **Riverstone** (-9.41), **Sydney** (+5.31) and **Winston Hills** (+7.27).
55. As with the draft determination, the Redistribution Panel has set these electoral districts towards the lower and upper ends of the allowable variance from the quotient as appropriate, with a view to balancing the projected variances at the relevant future date.
56. Section 21(2) of the Electoral Act also requires that the redistribution process takes into consideration 'relevant future trends', by calculating the projected number of electors at the relevant future time, which is 17 April 2023, i.e., four years after the return of the writs for the 2019 State General Election.
57. Of the electoral districts determined by the Redistribution Panel, there are only two that have projected variations from the quotient of more than five percent in 2023, namely **Barwon** at -7.45% and **Cootamundra** at -6.28%.
58. Moreover, even on the forecasts reconsidered by the demographer at the SA4 level, it is only suggested that three additional electoral districts have the potential to exceed the quotient by more than plus or minus five percent in 2023, namely **Camden**, **Heffron** and **Upper Hunter**.⁷ If this were to occur, it would still result in only 5.4% of the state's 93 electoral districts being outside of the quotient.
59. The full details of the variances from quotient of electoral districts as determined by the Redistribution Panel are listed in the '[Statistical summary of each electoral district](#)' table.

Potential for malapportionment under s 28A of the *Constitution Act 1902*

60. Under section 28A(1) of the Constitution Act, a distribution of New South Wales into electoral districts must be made 'forthwith after more than one-quarter of the number of electoral districts has been malapportioned for a period of more than 2 months'. For the purposes of section 28A, an electoral district is malapportioned at any particular time:

...if the number of persons then entitled to vote at a general election of Members of the Legislative Assembly in the electoral district differs from the average electoral district enrolment at that time to a greater extent than 5 per cent more or less: s 28A(2).
61. In the report accompanying the draft determination, the Redistribution Panel stressed that, under section 21(1)(a) of the Electoral Act, 'the primary determinant of NSW's electoral boundaries is future enrolment projections to give, as far as practicable, effect to the concept of 'one vote one value'. While section 21(1)(b) had to be read as a whole to 'provide an interlocking set of criteria to determine what is a community, rather than considering each element in that provision separately',⁸ the distribution criteria in section 21 are expressly subject to the Panel 'complying with sections 28 and 28A of the Constitution Act'.
62. Nonetheless, the report also highlighted that the Redistribution Panel had decided to utilise a larger variance from quotient in certain geographically large rural districts. The expressly limited application of this approach was not intended to suggest that the concept of 'communities of interest' would be relied upon to counter-weigh the need to balance as equally as possible the number of electors in electoral districts across New South Wales more generally.
63. The electoral districts as determined by the Redistribution Panel provide robust and definable boundaries and maintain strong communities of interest. The Redistribution Panel is confident that on these boundaries it is highly unlikely that a further redistribution would be triggered as a result of malapportionment.
64. Having said that, the Redistribution Panel also notes that, despite being able to make use of the best current technology, determining the boundaries of 93 electoral districts across the state of New South Wales was an extremely challenging process, especially having regard to the considerable geographic variations in the growth or decline of elector numbers. The difficulty in undertaking this task will only increase in the lead up to the next redistribution, which is expected to commence in 2028.

Final determination of names and boundaries of electoral districts in full

65. Pursuant to the provisions of s 27(2) of the Electoral Act, the Redistribution Panel has finally determined the names and boundaries of electoral districts as set out below.
66. For consistency, the Redistribution Panel has set out its determination with reference to the same regions of New South Wales as were used in the draft determination.
67. The constitution of each electoral district is set out in the table that accompanies each electoral district map.

Key proposals in the determination

68. The electoral district of **Lakemba** is abolished.
69. The electoral district of **Leppington** is created.
70. The following four electoral districts are re-named:
 - **Badgerys Creek** – formerly **Mulgoa**;
 - **Kellyville** – formerly **Baulkham Hills**;
 - **Wahroonga** – formerly **Ku-ring-gai**; and
 - **Winston Hills** – formerly **Seven Hills**.

Far West and Riverina-Murray

71. The Redistribution Panel has determined to make no changes to the electoral district of **Barwon**.
72. In accordance with its approach to making electoral district and LGA boundaries contiguous where possible in rural and regional NSW, the Redistribution Panel has determined to transfer that part of Murrumbidgee LGA currently within the electoral district of **Albury** (the former Jerilderie Shire Council) to the electoral district of **Murray**.
73. Similarly, the Redistribution Panel has determined to transfer that part of Hilltops LGA currently in the electoral district of **Goulburn** (Boorowa and surrounds – the former Boorowa Council) into the electoral district of **Cootamundra**.
74. The Redistribution Panel has determined to make only minimal adjustment to the boundaries of the electoral district of **Wagga Wagga**.

Central West

75. The Redistribution Panel has determined to move the northern boundary of the electoral district of **Bathurst** further northwards into the electoral district of **Upper Hunter**, to include the localities of Bylong, Coxs Creek, Lee Creek, Nullo Mountain and surrounds.
76. The Redistribution Panel has determined to transfer to the electoral district of **Dubbo** the localities of Cooks Gap, Ulan and Wollar, plus the surrounding localities, from the electoral district of **Upper Hunter**.
77. The Redistribution Panel has determined to make slight adjustments only to the boundaries of the electoral district of **Orange**.

New England-North West

78. The Redistribution Panel has determined to transfer to the electoral district of **Northern Tablelands** all of Walcha LGA from the electoral district of **Tamworth**.
79. The Redistribution Panel has determined to transfer to the electoral district of **Tamworth** all of the Liverpool Plains LGA from the electoral district of **Upper Hunter**.

North Coast

80. The Redistribution Panel has determined to transfer the localities of Eureka, Federal, Goonengerry and Huonbrook, and part of the locality of Wilsons Creek and surrounds from the electoral district of **Ballina** to the electoral district of **Lismore**.
81. The Redistribution Panel has determined to make no changes to the electoral district of **Coffs Harbour**.
82. The Redistribution Panel has determined to transfer part of the locality of North Woodburn from the electoral district of **Lismore** to the electoral district of **Clarence**.
83. The Redistribution Panel has determined to realign a small section of the boundary between the electoral districts of **Myall Lakes** and **Upper Hunter** to follow Belbora Creek Road at the northern end of the locality of Belbora.
84. The Redistribution Panel has determined to make the following changes to the electoral district of **Port Macquarie**:
 - (i) Transfer the localities of Lansdowne and Upper Lansdowne to the electoral district of **Myall Lakes**; and
 - (ii) Transfer the localities of Blackmans Point, King Creek, Telegraph Point and The Hatch to the electoral district of **Oxley**.
85. The Redistribution Panel has determined to retain Lord Howe Island within the electoral district of **Port Macquarie**, rather than transfer it to the electoral district of **Sydney**.
86. The Redistribution Panel has determined to make only slight adjustments to the boundaries of the electoral district of **Tweed**.

Hunter

87. The Redistribution Panel has determined to transfer into the electoral district of **Upper Hunter** from the electoral district of **Cessnock**:
 - (i) the localities of Broke, Howes Valley, Milbrodale, Mount Thorley and surrounds; and
 - (ii) the suburb of East Branxton and part of the suburb of Branxton.
88. The Redistribution Panel has determined to transfer to the electoral district of **Upper Hunter** all that part of Maitland LGA north of the Hunter River, from the electoral district of **Maitland**.
89. The Redistribution Panel has determined to realign a small section of the boundary between the electoral districts of **Myall Lakes** and **Upper Hunter** to follow Belbora Creek Road at the northern end of the locality of Belbora.
90. The Redistribution Panel has determined to make a minor adjustment to the boundary between the electoral districts of **Port Stephens** and **Upper Hunter** at the locality of Glen Oak.

Newcastle and Central Coast

91. The Redistribution Panel has determined to make the following changes to the electoral district of **Charlestown**:
 - (i) Transfer the suburb of Redhead to the electoral district of **Swansea**;
 - (ii) Transfer the remainder of the suburb of Cardiff Heights and part of the suburbs of Cardiff and Garden Suburb to the electoral district of **Wallsend**; and
 - (iii) Transfer the suburb of Cardiff South, and part of the suburbs of Cardiff and Warners Bay from the electoral district of **Lake Macquarie**.
92. The Redistribution Panel has determined to make the following boundary adjustments at the suburb of New Lambton:
 - (i) Transfer to the electoral district of **Charlestown** part of the suburb from each of the electoral districts of **Newcastle** and **Wallsend**; and
 - (ii) Transfer part of the suburb from the electoral district of **Newcastle** to the electoral district of **Wallsend**.⁹
93. The Redistribution Panel has determined to transfer the suburb of Cardiff South, and part of the suburbs of Cardiff and Warners Bay to the electoral district of **Charlestown** from the electoral district of **Lake Macquarie**.
94. The Redistribution Panel has determined to transfer to the electoral district of **Gosford** the remainder of the suburbs of Kulnura and Central Mangrove from the electoral district of **Wyang**; and to adjust the boundary with the electoral district of **Pittwater** in Broken Bay to align with the hydro line or the LGA boundary, as appropriate.
95. The Redistribution Panel has determined to make no changes to the electoral district of **Terrigal**.
96. The Redistribution Panel has determined to transfer to the electoral district of **The Entrance** the remainder of the suburb of Berkeley Vale from the electoral district of **Wyang**.

South Coast and Tablelands

97. The Redistribution Panel has determined to make no changes to the electoral districts of **Bega**, **Kiama** and **South Coast**.
98. The Redistribution Panel has determined to transfer part of Hilltops LGA (Boorowa and surrounds – the former Boorowa Council) from the electoral district of **Goulburn** to the electoral district of **Cootamundra**.
99. The Redistribution Panel has determined to retain the whole of the Queanbeyan-Palerang Regional LGA within the electoral district of **Monaro**, rather than transfer part of this LGA (namely the localities of Collector, Currawang, Tarago, and part of Lake George) to the electoral district of **Goulburn**, as was proposed in the draft determination. The Redistribution Panel has therefore determined to make no changes to the electoral district of **Monaro**.

Illawarra-Shoalhaven

100. The Redistribution Panel has determined to make the following changes to the electoral district of **Heathcote**:
 - (i) Transfer part of the suburbs of Bangor and Menai to the electoral district of **Holsworthy**;
 - (ii) Transfer part of the suburbs of Bangor and Menai to the electoral district of **Miranda**;
 - (iii) Transfer the suburbs of Austinmer, Coledale and Thirroul, and part of the suburb of Bulli from the electoral district of **Keira**; and
 - (iv) Transfer part of the suburb of Kirrawee from the electoral district of **Miranda**.

101. The Redistribution Panel has determined to make the following changes to the electoral district of **Keira**:
- (i) Transfer the suburbs of Austinmer, Coledale and Thirroul, and part of the suburb of Bulli to the electoral district of **Heathcote**;
 - (ii) Transfer the suburb of East Corrimal to the electoral district of **Wollongong**;
 - (iii) Transfer the suburbs of Cordeaux, Dombarton and Kembla Grange, and part of the suburb of Avon from the electoral district of **Shellharbour**; and
 - (iv) Transfer the suburb of Cordeaux Heights and part of the suburbs of Farmborough Heights, Kembla Heights, Mount Kembla and Unanderra from the electoral district of **Wollongong**.
102. The Redistribution Panel has determined to transfer from the electoral district of **Shellharbour** the suburbs of Brownsville and Kanahooka to the electoral district of **Wollongong**.

Outer Western Sydney

103. The Redistribution Panel has determined that the suburbs of Glenbrook and Lapstone be transferred to the electoral district of **Blue Mountains** from the electoral district of **Penrith**, such that the boundaries of the electoral district of **Blue Mountains** and the Blue Mountains LGA are contiguous.
104. The Redistribution Panel has determined to make the following changes to the electoral district of **Londonderry**:
- (i) Transfer the suburbs of Whalan, Tregear and Willmot and part of the suburbs of Emerton, Lethbridge Park, Mount Druitt and Shalvey to the electoral district of **Mount Druitt**;
 - (ii) Transfer the suburb of Werrington Downs and part of the suburbs of Cambridge Park and Castlereagh to the electoral district of **Penrith**;
 - (iii) Transfer the remainder of the suburbs of Caddens and Werrington, and part of the suburbs of Castlereagh, Cranebrook and Kingswood from the electoral district of **Penrith**; and
 - (iv) Transfer the suburb of Angus and part of the suburbs of Marsden Park, Schofields and Vineyard from the electoral district of **Riverstone**.
105. The Redistribution Panel has determined to make the following changes to the electoral district of **Penrith**:

 - (ii) Transfer the remainder of the suburbs of Caddens and Werrington and part of the suburbs of Castlereagh, Cranebrook and Kingswood to the electoral district of **Londonderry**; and
 - (iii) Transfer the suburb of Werrington Downs and part of the suburbs of Cambridge Park and Castlereagh from the electoral district of **Londonderry**.

North Western Sydney

106. The Redistribution Panel has determined to make the following changes to the electoral district of **Castle Hill**:
- (i) Transfer the suburbs of Box Hill, Gables and Nelson, part of the suburb of Rouse Hill, and the remainder of the suburb of Maraylya to the electoral district of **Hawkesbury**;
 - (ii) Transfer the suburbs of Beaumont Hills, Kellyville and North Kellyville, and part of the suburbs of Castle Hill and Rouse Hill to the electoral district of **Kellyville** (formerly **Baulkham Hills**);
 - (iii) Transfer part of the suburbs of Baulkham Hills, Castle Hill and West Pennant Hills from the former electoral district of **Baulkham Hills**;
 - (iv) Transfer part of the suburb of Castle Hill from the electoral district of **Epping**; and

107. The Redistribution Panel has determined to make the following changes to the electoral district of **Hawkesbury**:

 - (ii) Transfer the suburbs of Canoelands, Forest Glen, Laughtondale and Singletons Mill, and part of the suburbs of Glenorie, Middle Dural, Maroota and Wisemans Ferry to the electoral district of **Hornsby**; and
 - (iii) Transfer the suburbs of Box Hill, Gables and Nelson, part of the suburb of Rouse Hill, and the remainder of the suburb of Maraylya from the electoral district of **Castle Hill**.
108. The Redistribution Panel has determined to rename the electoral district of **Baulkham Hills** as **Kellyville**.
109. The Redistribution Panel has determined to make the following changes to the electoral district of **Kellyville**:
- (i) Transfer part of the suburbs of Baulkham Hills, Castle Hill and West Pennant Hills to the electoral district of **Castle Hill**;
 - (ii) Transfer part of the suburbs of Carlingford and North Rocks to the electoral district of **Epping**; and
 - (iii) Transfer the suburbs of Beaumont Hills, Kellyville and North Kellyville, and part of the suburbs of Castle Hill and Rouse Hill from the electoral district of **Castle Hill**.
110. The Redistribution Panel has determined that the boundary between the electoral districts of **Hawkesbury** and **Kellyville** will follow Second Ponds Creek and Caddies Creek at the suburb of Rouse Hill, rather than Annangrove Road.
111. The Redistribution Panel has determined to transfer from the electoral district of **Riverstone**:
- (i) The suburb of Angus and part of the suburbs of Marsden Park, Schofields and Vineyard to the electoral district of **Londonderry**; and
 - (ii) The suburb of Glenwood to the electoral district of **Winston Hills** (formerly **Seven Hills**).

South Western Sydney

112. The Redistribution Panel has determined to create a new electoral district in South Western Sydney, to be named **Leppington**.
113. The electoral district of **Leppington** shall consist of the following:
- (i) The suburb of Middleton Grange and part of the suburbs of Austral, Cecil Hills, Cecil Park, Kemps Creek and West Hoxton from the electoral district of **Badgerys Creek** (formerly **Mulgoa**);
 - (ii) The suburb of Rossmore and part of the suburbs of Austral, Catherine Field, Leppington, and West Hoxton from the electoral district of **Camden**;
 - (iii) Part of the suburb of Eagle Vale from the electoral district of **Campbelltown**;
 - (iv) Part of the suburb of Prestons from the electoral district of **Holsworthy**;
 - (v) The suburbs of Carnes Hill and Horningsea Park, and part of the suburbs of Hinchinbrook, Hoxton Park and West Hoxton from the electoral district of **Liverpool**; and

 - (ii) Transfer part of the suburbs of Kentlyn and Leumeah from the electoral district of **Macquarie Fields**; and
 - (iii) Transfer the suburb of Appin and part of the suburb of Cataract from the electoral district of **Wollondilly**.
118. The Redistribution Panel has determined to retain the boundary between the electoral districts of **Camden** and **Campbelltown** through the Australian Botanic Garden.
119. The Redistribution Panel has determined to make the following changes to the electoral district of **Holsworthy**:
- (i) Transfer part of the suburb of Prestons to the electoral district of **Leppington**;
 - (ii) Transfer part of the suburb of Casula to the electoral district of **Macquarie Fields**;
 - (iii) Transfer parts of the suburbs of Bangor and Menai from the electoral district of **Heathcote**;
 - (iv) Transfer part of the suburb of Alford's Point from the electoral district of **Miranda**; and
 - (v) Transfer part of the suburb of Liverpool from the electoral district of **Liverpool**.
120. The Redistribution Panel has determined to make the following changes to the electoral district of **Macquarie Fields**:
- (i) Transfer part of the suburbs of Kentlyn and Leumeah to the electoral district of **Campbelltown**;
 - (ii) Transfer part of the suburbs of Denham Court, Eagle Vale, Eschol Park, Kearns, Raby and Varroville to the electoral district of **Leppington**; and
 - (iii) Transfer part of the suburb of Casula from the electoral district of **Holsworthy**.
121. The Redistribution Panel has determined to transfer from the electoral district of **Wollondilly** the suburb of Appin and part of the suburb of Cataract to the electoral district of **Campbelltown**.

Middle Western Sydney

122. The Redistribution Panel has determined to abolish the electoral district of **Lakemba**, and subsume much of it into a redrawn electoral district of **Bankstown**.
123. The Redistribution Panel has determined to make the following changes to the electoral district of **Bankstown**:
- (i) Transfer the suburbs of Chullora, Greenacre, Mount Lewis, and Punchbowl, and part of the suburbs of Bankstown, Beverly Hills, Narwee, Riverwood, Roselands, Wiley Park and Yagoona from the abolished electoral district of **Lakemba**;
 - (ii) Transfer the suburbs of Birrong, Potts Hill and Sefton, and parts of the suburbs of Bass Hill, Chester Hill, Regents Park and Yagoona to the electoral district of **Auburn**;
 - (iii) Transfer part of the suburbs of Yagoona, Bass Hill and Bankstown to the electoral district of **East Hills**;

125. The Redistribution Panel has determined to make the following changes to the electoral district of **Blacktown**:¹¹

- (i) Transfer part of the suburb of Canley Vale to the electoral district of **Cabramatta**;
 - (ii) Transfer the suburbs of Guildford West and Woodpark and part of the suburbs of Guildford, Smithfield and Yennora to the electoral district of **Granville**; and
 - (iii) Transfer the suburb of Lansdowne and part of the suburbs of Bass Hill, Chester Hill, Georges Hall and Villawood from the electoral district of **Bankstown**.

131. The Redistribution Panel has determined to make the following changes to the electoral district of **Liverpool**:

 - (iv) Transfer the suburb of Bonnyrigg Heights and part of the suburbs of Bonnyrigg and Mount Pritchard from the electoral district of **Cabramatta**.
132. The Redistribution Panel has determined the following changes to the electoral district of **Mount Druitt**:
- (i) Transfer the suburbs of Colebee, Dean Park and Glendenning, and part of the suburb of Rooty Hill to the electoral district of **Blacktown**; and
 - (ii) Transfer the suburbs of Tregear, Whalan and Willmot and part of the suburbs of Emerton, Lethbridge Park, Mount Druitt and Shalvey from the electoral district of **Londonderry**.
133. The Redistribution Panel has determined to make the following changes to the electoral district of **Parramatta**:
- (i) Transfer the suburbs of Dundas Valley, Oatlands and Telopea, and part of the suburbs of Carlingford, Dundas, North Parramatta and North Rocks to the electoral district of **Epping**;
 - (ii) Transfer the suburbs of Newington, Silverwater, Sydney Olympic Park and Wentworth Point, and part of the suburb of Lidcombe from the electoral district of **Auburn**;
 - (iii) Transfer the suburb of Clyde, and parts of the suburbs of Granville, Mays Hill and Parramatta from the electoral district of **Granville**; and
 - (iv) Transfer part of the suburb of Westmead from the electoral district of **Winston Hills** (formerly **Seven Hills**).
134. The Redistribution Panel has determined to make the following changes to the electoral district of **Prospect**:

 - (v) Adjust the boundary between the electoral districts of **Newtown** and **Summer Hill** at Malthouse Way, Lewisham, so as to align with the Sydney Light Rail line.
143. The Redistribution Panel has determined to make the following changes to the electoral district of **Strathfield**:
- (i) Transfer the suburb of North Strathfield and part of the suburbs of Concord West and Homebush to the electoral district of **Drummoyne**;
 - (ii) Transfer part of the suburbs of Belfield and Campsie from the electoral district of **Canterbury**; and
 - (iii) Adjust the boundary between the electoral districts of **Canterbury** and **Strathfield** at the suburb of Campsie, to retain the whole of the Campsie town centre within the electoral district of **Canterbury**.
144. The Redistribution Panel has determined to make the following changes to the electoral district of **Summer Hill**:
- (i) Transfer the suburb of Lewisham and part of the suburb of Petersham to the electoral district of **Newtown**;
 - (ii) Transfer the suburb of Hurlstone Park and part of the suburb of Ashbury from the electoral district of **Canterbury**; and
 - (iii) Adjust the boundary between the electoral districts of **Newtown** and **Summer Hill** at Malthouse Way, Lewisham, so as to align with the Sydney Light Rail line.
145. The Redistribution Panel has determined to make the following changes to the electoral district of **Sydney**:
- (i) Transfer part of the suburbs of Edgecliff and Woollahra to the electoral district of **Vaucluse**;
 - (ii) Transfer the suburbs of Centennial Park and Moore Park from the electoral district of **Heffron**; and
 - (iii) Transfer the suburb of Surry Hills from the electoral district of **Newtown**.
146. The Redistribution Panel has determined to retain Lord Howe Island within the electoral district of **Port Macquarie**, rather than transfer it to the electoral district of **Sydney**.
147. The Redistribution Panel has determined to transfer part of the suburbs of Edgecliff and Woollahra to the electoral district of **Vaucluse** from the electoral district of **Sydney**.

Sydney – Northern Districts

148. The Redistribution Panel has determined to retain the name **Davidson** rather than the Panel's proposed electoral district name of **St Ives**.
149. The Redistribution Panel has determined to make the following changes to the electoral district of **Davidson**:
- (i) Transfer part of the suburbs of Belrose, Forestville, Ingleside, Oxford Falls and Terrey Hills to the electoral district of **Wakehurst**;
 - (ii) Transfer the suburb of Castle Cove to the electoral district of **Willoughby**; and
 - (iii) Transfer the suburb of North Turramurra and part of the suburbs of Gordon, Killara and Turramurra from the electoral district of **Wahroonga** (formerly Ku-ring-gai).

150. The Redistribution Panel has determined to make the following changes to the electoral district of **Epping**:
- (i) Transfer part of the suburb of Castle Hill to the electoral district of **Castle Hill**;

 - (iii) Transfer part of the suburbs of Carlingford, Eastwood and Epping to the electoral district of **Ryde**;

 - (ii) Transfer the suburb of Cherrybrook and part of the suburbs of Dural, Pennant Hills and West Pennant Hills from the electoral district of **Epping**; and
 - (iii) Transfer the suburbs of Canoelands, Forest Glen, Laughtondale and Singletons Mill and part of the suburbs of Glenorie, Maroota, Middle Dural and Wisemans Ferry from the electoral district of **Hawkesbury**.
152. The Redistribution Panel has determined to make the following changes to the electoral district of **Lane Cove**:
- (i) Transfer part of the suburbs of Artarmon and St Leonards to the electoral district of **Willoughby**;
 - (ii) Transfer part of the suburb of North Ryde from the electoral district of **Ryde**; and
 - (iii) Adjust the boundary between the electoral districts of **Lane Cove** and **Willoughby**, at the suburb of Lane Cove North, in order to include the entire Willoughby LGA in the electoral district of **Willoughby**.
153. The Redistribution Panel has determined to transfer to the electoral district of **Manly** part of the suburbs of Allambie Heights, Dee Why and Manly Vale (namely, the University of NSW Manly Vale Campus) from the electoral district of **Wakehurst**.
154. The Redistribution Panel has determined to transfer the suburb of St Leonards from the electoral district of **North Shore** to the electoral district of **Willoughby**.
155. The Redistribution Panel has determined to make the following minor boundary adjustments to the electoral district of **Pittwater**:
- (i) Adjust the boundary between the electoral districts of **Pittwater** and **Gosford** in Broken Bay to align with the hydro line or the LGA boundary, as appropriate; and
 - (ii) Adjust the boundary between the electoral districts of **Pittwater** and **Wakehurst**, to include the whole suburb of Wheeler Heights in the electoral district of **Wakehurst**.

 - (iv) Adjust the boundary between the electoral districts of **Canterbury** and **Strathfield** at the suburb of Campsie, to retain the whole of the Campsie town centre within the electoral district of **Canterbury**.

162. The Redistribution Panel has determined to make no changes to the electoral district of **Cronulla**.
163. The Redistribution Panel has determined to transfer to the electoral district of **Kogarah**:
- (i) Parts of the suburbs of Blakehurst and Kyle Bay from the electoral district of **Oatley**; and
 - (ii) Part of the suburb of Kogarah Bay from the electoral district of **Rockdale**.
164. The Redistribution Panel has determined to make the following changes to the electoral district of **Miranda**:
- (i) Transfer part of the suburb of Kirrawee to the electoral district of **Heathcote**;
 - (ii) Transfer part of the suburb of Alfords Point to the electoral district of **Holsworthy**; and
 - (iii) Transfer part of the suburbs of Bangor and Menai from the electoral district of **Heathcote**.
165. The Redistribution Panel has determined the following changes to the electoral district of **Oatley**:
- (i) Transfer part of the suburbs of Blakehurst and Kyle Bay to the electoral district of **Kogarah**; and
 - (ii) Transfer part of the suburbs of Beverly Hills, Narwee and Riverwood from the abolished electoral district of **Lakemba**.
166. The Redistribution Panel has determined to transfer part of the suburb of Kogarah Bay from the electoral district of **Rockdale** to the electoral district of **Kogarah**.

Constitution of each electoral district

The following tables describe the composition of each of the 93 electoral districts by reference to the sum of electors within the boundaries of existing electoral districts. These enrolment figures are given as at 23 March 2020, being the date as at which enrolment figures were taken for the purposes of this redistribution, and referred to as 'current enrolment 2020'; and as at 17 April 2023, being the 'relevant future time' referred to in section 21(1)(a) of the Electoral Act, and referred to as 'future enrolment 2023'.

The tables include a number of entries with zero enrolments, current or projected. This is because they include areas that are typically non-residential – e.g., parks, industrial zones, or waterways – and therefore have no resident electors. Additionally, the redrawing of electoral districts has resulted in some small area transfers (generally less than 1 sq km) in which a boundary has been re-aligned for improved cartographic representation. These include electoral districts in which a section of the boundary has been redrawn to follow a more definable feature, but has not changed in enrolment terms. These electoral districts will therefore contain a small section of an existing electoral district which includes no electors.

Note that references to unincorporated areas refer to those areas which are not part of any Local Government Area, including the Unincorporated Far West region of NSW and unincorporated waterways.
