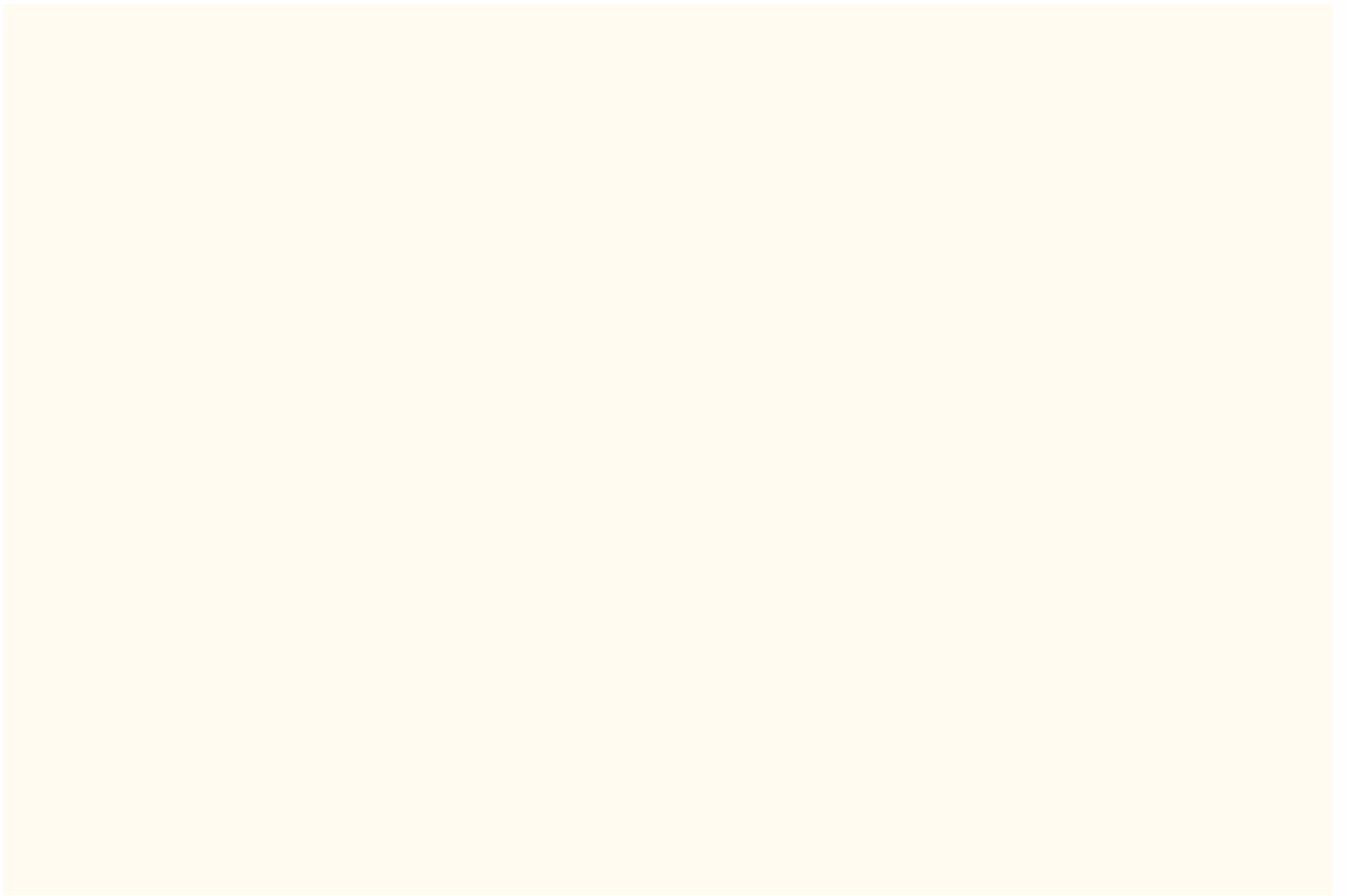
ABOLITION OF VOTING CENTRES DESIGNATED AS EARLY VOTING CENTRES

1. Under s 108(5) of the Act the Commissioner may abolish any voting centre appointed under s 108.
2. With respect to the attached Schedule B, I abolish the venue in Column A at the address in Column B as a voting centre for the corresponding electoral district listed in Column C for the election.
3. Pursuant to s 108(5) of the Act, I determine that notice of the abolition of the voting centres be published on the NSW Electoral Commission website as soon as practicable after this instrument is made.

2. I abolish Queanbeyan-Palerang Regional Office, Bungendore at 10 Majara Street, Bungendore as a voting centre for the electoral district of Monaro for the state general election to be held on 25 March 2023.
3. Pursuant to section 108(5) of the Act, I determine that notice of the abolition of the Queanbeyan-Palerang Regional Office voting centre be published on the NSW Electoral Commission website as soon as practicable after this instrument is made.

ABOLITION OF EARLY VOTING CENTRE

1. Under section 108(5) of the *Electoral Act 2017* (**the Act**) the Electoral Commissioner may abolish any voting centre appointed under section 108 of the Act.
2. I abolish the Auburn Election Manager's Office at First Floor, 326 - 332 Hume Highway, Bankstown, NSW as an early voting centre for the electoral districts of Auburn and Bankstown for the state general election to be held on 25 March 2023.
3. Pursuant to section 108(5) of the Act, I determine that notice of the abolition of the Auburn Election Manager's Office early voting centre be published on the NSW Electoral Commission website as soon as practicable after this instrument is made.
