 - a. section 137(2) of the Act for a person whose name is not on the authorised roll at a voting centre and who claims to be entitled to enrol for the district; and
 - b. section 137(3) of the Act for a person who is not enrolled for any district and claims to be entitled to enrol; and
 - c. section 137(4) of the Act for a person enrolled for a district but who claims to be entitled to enrol for another district; and
 - d. section 137(5) of the Act for a person who is enrolled for a district but whose name does not appear on the authorised roll at a voting centre in that district.

Assistance

If an elector is unable to mark, sign and complete an electoral paper without assistance or is under a religious obligation not to mark an electoral paper with his or her own hand, the person may appoint another person to mark the ballot paper or sign and complete the electoral paper on that person's behalf.

What happens when you return your form?

Your application is checked and your name and address are placed on the electoral roll for federal, state and local government elections if you are eligible.

Who has access to your enrolment information?

The Australian Electoral Commission (AEC) and the NSW Electoral Commission (NSWEC) have legislative authorisation to collect the information on this form, and to exchange your information for enrolment purposes; to maintain electoral rolls and registers; and verify the information with document issuing authorities and other Commonwealth.
