#### Requirements for appointment as scrutineer

- · Scrutineers must be enrolled to vote in NSW.
- Scrutineers must be appointed by a candidate or registered political party.
- Only the lead candidate of a group for the Legislative Council may appoint scrutineers. The other candidates in the group must not appoint scrutineers.

#### Candidates for election may only be appointed as a scrutineer in the following circumstances:

- A Legislative Assembly candidate cannot be appointed as a scrutineer for the district they are contesting but
  may be appointed as scrutineer for another Legislative Assembly district or the Legislative Council.
- A lead candidate in a Legislative Council group or ungrouped candidate for the Legislative Council cannot be appointed as a scrutineer for the Legislative Council but may be appointed as a scrutineer for a Legislative Assembly district.
- Candidates in a group who are not the lead candidate may be appointed as a scrutineer for either the Legislative Council or a Legislative Assembly district.

#### **Scrutineer undertaking**

#### I will not:

- either directly or indirectly, divulge or communicate any information with respect to the vote of an elector
  acquired by me in the performance of my duties or functions in a manner that is likely to enable the identification
  of an elector.
- · interfere with or attempt to influence any elector or election official,
- communicate with any person in a voting centre or ballot counting place except so far as is necessary to discharge
  my duties or functions,
- ignore lawful directions of a voting centre manager or person in charge of a ballot counting place, or
- use any device to film or record election processes.

#### I will:

- inform myself of my obligations and the relevant offence provisions under the Electoral Act 2017.
- · inform myself of the NSWEC Scrutineer Policy.
- · carry out my duties and functions in accordance with the Electoral Act 2017 and NSWEC Scrutineer Policy, and
- at all times, wear the scrutineer identification supplied to me by NSWEC when within a voting centre or ballot counting place.
